2015 ANNUAL REPORT



Day Kimball Healthcare reported a consolidated loss of \$6.3 million for Fiscal Year 2015, which runs from October 1, 2014 through September 30, 2015.

Revenue

A moderate decline in volume of services occurred, which was largely consistent with current healthcare industry trends. This, combined with a \$1.1 million rescission in state funding and significant reductions in Medicaid reimbursement rates for several key services, resulted in a \$6.5 million decline in revenue.

Expenses

In 2015 Day Kimball Healthcare implemented an expense reduction plan designed to streamline operations and create new efficiences. We were successful in carrying out that plan, which resulted in a \$1 million improvement from initial FY15 budget projections and nearly a \$6.5 million reduction in expenses as compared to FY14. However it was not enough to achieve a positive bottom line given the significant reductions in funding and reimbursement rates and the decline in volume of services.

To offset those effects, efforts will continue into our Fiscal Year 2016, during which we will implement a new expense reduction plan totaling \$7 million in annualized savings. This plan is projected to have Day Kimball end Fiscal Year 2016 with a break-even bottom line.

Achievements

Despite and amidst the continued financial and industry-driven challenges of Fiscal Year 2015, Day Kimball Healthcare earned significant achievements in quality measures, accreditations, certifications and services to improve the overall health of the communities we serve. 
